

**NOTICE OF 100TH ANNUAL GENERAL MEETING, BOOK CLOSURE
AND REMOTE E-VOTING ETC.**

The 100th Annual General Meeting (AGM) of the Company will be held on Thursday, 9th August, 2018 at 03.30 p.m. at 'DHUNSERI HOUSE', 4A Woodburn Park, Kolkata-700020 to transact the business as set forth in the Notice of the Meeting dated 28th May, 2018.

(1) The Annual Report 2017-18 inter-alia containing the Notice of the AGM, Attendance Slip and Proxy Form have been dispatched to the Members through permitted mode. The same are also available on the website of the Company at www.nagadhunserigroup.com and also on NSDL's website at <http://www.evoting.nsd.com>.

The Register of Members and Share Transfer Books of the Company will remain closed from Friday, 3rd August, 2018 to Thursday, 9th August, 2018 (both days inclusive).

(2) The Company is providing e-voting facility to all its Members to enable them to cast their votes electronically on all the resolutions set forth in the aforesaid Notice dated 28th May, 2018.

(3) The Members, whose names appear in the Register of Members as on the cut-off date i.e. Thursday, 2nd August, 2018 are entitled to vote on all the resolutions set forth in the Notice. The Members holding shares of the Company either in physical or in dematerialized form, as on the said cut-off date, may cast their votes electronically.

(4) Members who have acquired shares after the dispatch of the Annual Report & Accounts but before the book closure, may obtain the user ID and Password by sending a request at evoting@nsdl.co.in.

Please refer the instructions for e-voting given in Note No. 10 of the aforesaid 100th AGM Notice.

(5) The e-voting period commences on Monday, August 6, 2018 at 9.00 a.m. and ends on Wednesday, August 8, 2018 at 5.00 p.m. The e-voting module shall be disabled by NSDL at 5.00 p.m. on 8th August, 2018 and remote e-voting shall not be allowed beyond the said date and time.

(6) The facility for physical voting shall also be made available at the venue of the AGM and the Members attending the AGM who have not cast their vote by remote e-voting or through Ballot Form, shall be eligible to vote at the AGM.

(7) The voting rights of the Members shall be in proportion to their share in the paid-up equity share capital of the Company as on the cut-off date i.e. Thursday, 2nd August, 2018.

(8) A member may participate in the AGM even after exercising his right to vote through remote e-voting or Ballot Form but shall not be allowed to vote again in the meeting.
