#### INDEPENDENT AUDITORS REVIEW REPORT

# TO THE BOARD OF DIRECTORS OF NAGA DHUNSERI GROUP LIMITED

We have reviewed the accompanying Statement of Standalone Unaudited Financial Results of NAGA DHUNSERI GROUP LIMITED for the Quarter and three months ended 30th June, 2018.
